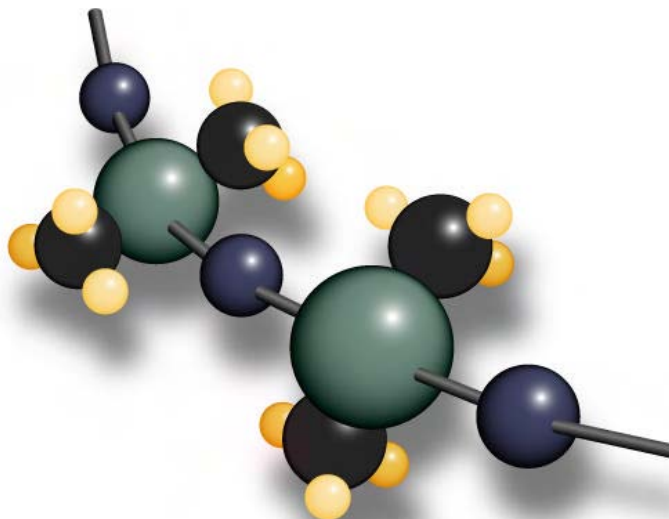

Each of the MED-4502 color masterbatches is supplied as a single component material. Easily combine in desired proportions with other high consistency materials on a two-roll mill. Suggested concentration is 2 pph masterbatch by weight. Combine and cross-blend components until thoroughly mixed. Take the usual precautions to avoid contamination of the materials.
