- For applications requiring a broader operating temperature range

#### INSTRUCTIONS FOR USE

Stir prior to use, as the product separates. Apply by spraying, dipping or brushing. Thin with VM&P Naphtha (NuSil Technology R-1001) to the appropriate viscosity for spray equipment. Mix with a moisture free solvent in a closed container, preferably with a commercial paint shaker.

Caution: Consult the MSDS for CV2-1147 prior to use, as the solvent carrier is hazardous.

#### Inhibition Concerns

Although generally considered to be non-corrosive to most substrates, the oxime cure system may cause discoloration in the presence of copper or copper alloys.

Note: Some bonding applications may require the use of a primer. NuSil Technology SP-120 silicone primer is recommended.

#### **OPERATING TEMPERATURE**

The operating temperature range of a silicone in any application is dependent on many variables, including but not limited to: temperature, time of exposure, type of atmosphere, exposure of the material's surface to the atmosphere, and mechanical stress. In addition, a material's physical properties will vary at both the high and low end of the operating temperature range. This type of silicone typically remains flexible at extremely low temperatures and has been known to perform at -120°C (-248°F) as well as resist breakdown at elevated temperatures up to 300°C (572°F).
