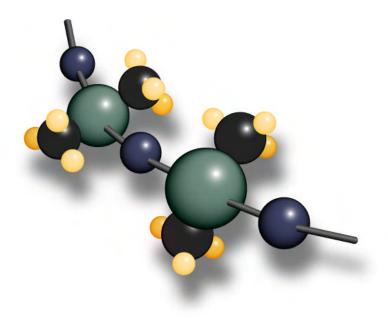

### Instructions for Use

#### **Substrate Considerations**

Cures in contact with most materials. Exceptions include: unreacted residues of some curing agents, butyl and chlorinated rubbers, and some RTV silicones containing organotin and/or amines.

**Note**: Some bonding applications may require the use of a primer. NuSil Technology CF1-135 silicone primer is recommended.

#### Mixing

Thoroughly mix R-2356 prior to catalyst addition ensuring uniformity in the cured foam. Mix Part A with Part B for 30-60 seconds, introducing air while mixing. High-speed agitation with a power mixer results in a lower density foam. Quickly pour the mixed material into the application site. Handle material within about 10 minutes after pouring, allow 24 hours for optimum physical properties. Confining the foam results in a higher specific gravity.

**Caution:** The cure exhibits an exotherm of 20°C (36°F) and the evolution of hydrogen gas. Exercise appropriate caution, keep away from open flame and use only with adequate ventilation.
